Advanced Emergency Braking System

(Standard on all versions)

An intelligent autonomous braking system designed to avoid a collision or limit its severity by reducing the vehicle's speed. The system is triggered if the driver does not react quickly enough, by activating the vehicle's brakes.

Lane Keeping Assist

(Standard on all versions)

This intelligent system positions the car centrally in the lane of travel, applying left and right trajectory corrections accordingly, whilst the adaptive cruise control maintains speed and distance from the traffic ahead.

Adaptive Cruise Control with Stop & Go Function

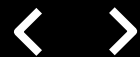
